
## Notice of Commencement of Environmental Assessment and Notice of PIC #1 for the Scarborough Waterfront Project Toronto and Region Conservation Authority (TRCA)

TRCA is beginning an Environmental Assessment under the *Environmental Assessment Act* to create a system of greenspaces along the Lake Ontario shoreline between Bluffer's Park and East Point Park in Toronto, Ontario. The vision of the Scarborough Waterfront Project is to create a system of greenspaces along the Lake Ontario shoreline which respect and protect the significant natural and cultural features of the Bluffs, enhance the terrestrial and aquatic habitat, and provide a safe and enjoyable waterfront experience.

## The Process

On December 15, 2015, the Minister of the Environment and Climate Change approved



the Terms of Reference for the Scarborough Waterfront Project. A copy of the approved Terms of Reference is available at the TRCA Head Office at 101 Exchange Ave, Vaughan, ON L4K 5R6 or at any time on the project website: www.trca.on.ca/swp.

This study will be carried out according to the approved Terms of Reference and the requirements of the *Environmental Assessment Act*. Results from this study will be documented in an Environmental Assessment, which will be submitted to the ministry for a review. At that time, the public, Aboriginal communities and other interested persons will be informed when and where the Environmental Assessment can be reviewed.
